

THE SECURITIES ACT (BLOODSTOCK) EXEMPTION NOTICE 2012**VETERINARY CERTIFICATE FOR BLOODSTOCK****1 Examination Procedures**

Prior to issuing this certificate I have:

- (a) Examined the records of breeding and/or racing history supplied to me by the Syndicate/Promoter in respect of the bloodstock described in the schedule to this certificate.
- (b) Physically examined the bloodstock described in the schedule to the extent requested by the Syndicator/Promoter.
- (c) The examination of a horse for purchase is a process which can vary significantly depending upon the requirements of the person requesting the examination.

In addition to the 5 stage procedure recommended by the New Zealand Equine Veterinary Association (NZEVA) radiological, fertility, pregnancy or other special testing procedures may be carried out. Full examination/tests certificates have been provided to the Syndicate/Promoter for both the various stages of the NZEVA test and for any other special tests carried out. In order to fully understand the nature and extent of the examination, reference should be made to the full certificate of Veterinary examination and to the Syndicate/Promoter.

- (d) This certificate is not a certificate of veterinary examination but a certificate required for the purposes of the Securities Act. You should note that this certificate does not reach any conclusion as to the "suitability for purchase" of any horse. It details the examination carried out and, where possible, provides a summary of the findings of any examination. Decisions as to the suitability for purchase of any horse are a matter for the purchaser based on a number of factors including the results of a veterinary examination.

2 Declaration of Interest

I hereby certify that:

- (a) I hold a current practising certificate issued by the Veterinary Council of New Zealand.
- (b) I am experienced in equine practice and spend the majority of my professional time in equine practice.
- (c) I do not have a direct or indirect interest in the syndicate/promoter offering its share or shares/units in the bloodstock described in the schedule to this certificate or his/her/its business.
- (d) I do not have a direct or indirect pecuniary interest in any of the bloodstock described in the schedule of this certificate, except in respect of the provision of this certificate.
